Welcome to the 2nd AGM of the DSGC Charitable Trust, and our first full year.

We have been delighted with all the donations that have been coming in to the Trust, including the initial Amazon Smile contributions and the individual contributions from members. Sally has done a great job of raising the profile of the Trust through raffle draws at the AGM, at Competition Enterprise and a challenge at the Dunkeswell 80th Anniversary. We also would like to thank JB for his donation following the sale of K6 HEB. The Ian King K6 DRE fund has now been incorporated in the Trust.

More recently we have set up the Trust as a cause that can be selected on EasyFundRaising which covers more than 7000 major online brands. We currently have 19 Supporters here and of these, 5 are very actively purchasing items online which feeds through to various donations. If we could get more supporters / purchasers there is potentially lots of free money available. We can show you how to set this up if you wish.

The Trust has already started supporting K6 DRE, by funding the DRE Insurance and upgrading / repairing some instruments. But the Trust is for all Members who can request grants for small projects - please see the grant-making policy on the website.

Payments out to date have solely been to keep DRE airborne:

- March £882 Power Flarm
- October £738 Insurance
- January £315 Vario

So in all a great year, where we have also registered for Easyfundraising, which although may bring in a smaller income, is very welcome, and easily obtained. We just need to promote this to more members. I have also just submitted Gift Aid claim up to end of our Financial Year 31 January 2024 for £1,109.98.
